

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.mcdonaldstoneco.com](http://www.mcdonaldstoneco.com), and Sandblasted Stone Signs, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Sandblasted Stone Signs, LLC include [www.mcdonaldstoneco.com](http://www.mcdonaldstoneco.com) and McDonald Stone Co.. The McDonald Stone Co. website is a custom stone signage and memorial site. By using the McDonald Stone Co. website, you consent to the data practices described in this statement.

## Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Sharing Information with Third Parties

McDonald Stone Co. does not sell, rent or lease its customer lists to third parties.

McDonald Stone Co. may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to McDonald Stone Co., and they are required to maintain the confidentiality of your information.

McDonald Stone Co. may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on McDonald Stone Co. or the site; (b) protect and defend the rights or property of McDonald Stone Co.; and/or (c) act under exigent circumstances to protect the personal safety of users of McDonald Stone Co., or the public.

## Automatically Collected Information

Information about your computer hardware and software may be automatically collected by McDonald Stone Co.. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the McDonald Stone Co. website.

## Use of Cookies

The McDonald Stone Co. website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies

cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

- SSL Protocol

- Comply with an existing legal obligation; or
